EMERGENCY NEEDS ASSISTANCE GRANT

The office of Services to the Aging has allocated funds to be used to pay for fuel costs or other emergency needs of older adults. These needs may include financial assistance for high utility bills, minor home repair, prescription medication or the purchase of fuel. Eligibility will be determined by income, need and other available resources. Eligible income level is based on 150% of the poverty guideline. Program managers will work closely with the Department of Social Services, Eight-Cap and other assistance programs to fill service gaps and avoid duplication.

The grant will begin April 1, 1986 and continue through September 30, 1986 or until funds are depleted. If you would like more information please call the Commission on Aging at 772-0748.


NEWS FLASH

HAZARDOUS WASTE AND YOUR HEALTH

Every year 10 million tons of solid waste are deposited somewhere in the State of Michigan. A portion of this waste is hazardous waste which can injure living things - some are also life-threatening. People accumulate hazardous waste and the amount and variety is greatly increasing.

A hazardous waste is a discarded substance whose chemical or biological nature make it potentially dangerous to people. Characteristics that make a waste hazardous are: explosive, highly flammable, or having the tendency to react violently with other substances; corrosive materials; or toxic materials which are poisonous or can cause cancer, birth defects or other health problems. Along with the materials identified as being hazardous wastes, the EPA has also compiled a list of hazardous waste substances which by 1985 contained more than 200 substances.

A Household Hazardous Waste Collection Day has been set for October 4, 1986 at the Mt. Pleasant Shopping Center parking lot. As a forerunner to this collection day, educational presentations can be made to local groups or organizations upon request and elementary school children will be receiving a presentation this fall.

VOCATIONAL REHABILITATION FOR DISABLED PEOPLE



A person who applies for disability benefits under either the Social Security or supplemental security income program may be considered for services offered by the State Vocational Rehabilitation Agency. These services include counseling and guidance, medical and surgical treatment, physical therapy, training in the use of prostheses, and job training and placement.

Applications for disability payments are sent by Social Security to the appropriate agency in the State in which the applicant lives. It is this agency that determines whether the individual is disabled or blind within the meaning of the law.

If it is determined that the available vocational rehabilitation services would assist the applicant in obtaining employment, he or she is interviewed by a counselor. The fact that a person accepts vocational rehabilitation services does not affect his or her eligibility for disability payments; however, refusing these services will rule out benefit payments unless there is good reason for the refusal.

Although disability checks usually stop shortly after a person's condition improves to the point that he or she can once more work, an exception applies to beneficiaries who were disabled at the time they started an approved vocational rehabilitation plan, but who unexpectedly recover before the program is completed. In such cases, payment may continue if it is believed that the vocational rehabilitation services will permit a return to work.



COMPUTER CENTER PROJECT

One of the projects of the Tribal Educational Board, the Computer Center, got off the ground last week. The new director and instructor for the program, Richard Tilmann, was hired and he started work. Mr. Tilmann has had many years experience as both a teacher and as a computer professional.

The Computer Center project was originally a part of the Indian School program. Although the larger school program has been delayed, the grant for the Computer Center has been awarded. It is a cooperative program between the Saginaw Chippewa Indian Tribe and the Hannahville School program. The purpose of the program is to provide access to micro computers and the training to use them in a variety of ways. Both children and adults are encouraged to make use of this new resource.

The Computer Center will be located in the southern half of the Headstart building, where the housing office used to be. Four Apple II computers and a printer will be available. A wide variety of 'software', or computer programs and books are also being collected. We are planning to have it open and staffed in the afternoons and Monday thru Thursday evenings, although the exact hours has not yet been determined.

There will be three major activities at the Computer Center, the Computer Literacy program, Instructional Tutoring and Adult Education.

The Computer Literacy program is designed for children and teenagers who want to learn about computers and computer programming. The emphasis of this part of the Center is using personal computers for fun and growth.

The Instructional Tutoring program is designed to help some of the school aged children who are having trouble with their math, science, or language classes. A large library of educational programs is available to the Center through the Mt. Pleasant School system and Central Michigan University.

The third part of the program is the Adult Education. This is designed to offer individualized training to the adult members of the reservations who wish to improve their professional skills. This includes word processing and data entry training.
